Thank you for choosing to enrol your child at Rollins Primary School.

- Last school, Kinder or Day Care attended.
- Melways Map reference and distance to school
- A minimum of two local emergency contacts (not including parents/carers already listed)
- Medicare number
- All relevant medical history for child

Be sure to fill in all of the forms.

Once you have completed all forms, please submit your application to the general office – with your child's:

1. Original birth certificate or passport
2. Immunisation certificate.

Photocopies of these will be kept at the school and the originals returned to you.

Please ask at the office if you are unsure of any details. We are happy to assist.

Proof Of Address

It is an Education Department recommendation that children attend the local government primary school closest to their home address. This means that Rollins Primary School must first cater to our immediate surrounding families. To keep this process fair, proof of your address, such as rental agreement or utility bill may be required to be presented.

If you choose not to provide some or all of the information asked for we may not be able to enrol your child at Rollins Primary School.
